BILL OF SALE: This bill of sale is executed this ____ day of _____, _____. The Seller hereby transfers to Buyer all rights, title and interest in accordance with the laws of California and subject to the following terms and conditions:

- **PUPPY IS SOLD ON AKC LIMITED REGISTRATION UNLESS OTHERWISE AGREED UPON.** This is a non-breeding registration. Limited registration means that this animal cannot compete in confirmation shows, but can compete in obedience and field events. Any offspring of the animal is not eligible for AKC registration. Buyer agrees that this puppy is not being sold for the purposes for breeding and shall not be bred unless otherwise stated.
- Buyer agrees **NOT** to spay or neuter puppy prior to 12 months of age. Seller highly recommends to wait until 18 months of age; to allow for maturity and help prevent orthopedic disorders and other long term health problems associated with early spay/neuter.
- All Lone Spring Ranch Labradors puppies will carry the name "Lone Spring" on their AKC registration papers.
- **ONE YEAR UNCONDITIONAL GUARANTEE.** Should Buyer become unsatisfied with his/her puppy in its first year, the puppy may be returned for a refund of the purchase price as stated in this contract or a replacement from a future litter. Any charges or costs incurred while puppy is in the ownership, custody and/or care of the Buyer is their responsibility and Seller is not responsible for any such costs. Buyer will incur all costs associated with returning said puppy to Seller.

BUYER'S WARRANTIES: Buyer agrees to provide responsible veterinary care, proper food, water, shelter, exercise and adequate companionship. Puppy may never in its lifetime be on a chain.

- **BUYER AGREES, SHOULD EVIDENCE EVER BE PRESENTED TO SELLER THAT THE PUPPY HAS BEEN ABUSED, NEGLECTED OR DENIED MEDICAL ATTENTION, OWNERSHIP IN THE PUPPY SHALL REVERT BACK TO THE SELLER WITH IMMEDIATE EFFECT, AND THE BUYER AGREES TO ALLOW THE SELLER IMMEDIATE ACCESS TO THE PUPPY FOR PURPOSES OF REPOSSESSION. BUYER AGREES THAT ALL FEES AND CHARGES INCURRED FOR REPOSSESSION AND/OR MEDICAL ATTENTION OF THIS PUPPY TO RESTORE PROPER HEALTH WILL BE THE RESPONSIBILITY OF BUYER**

AND SHALL BE PAID TO SELLER UPON RECEIPT. ALL CHARGES WILL BE IN CLEAR LANGUAGE AND DOCUMENTED BY A LICENSED VETERINARIAN.

- Buyer agrees that, if for any reason during the lifetime of said puppy, Buyer and/or Buyer's family can no longer keep him/her in their possession, they will relinquish ownership back to Stacy O'Hagan/Lone Spring Ranch Labradors. Under no circumstances is Buyer to "give away" dog to any rescue group, shelter, or any other type of facility for re-homing or disposal. Buyer shall contact Stacy O'Hagan immediately and hereby agrees to return Labrador to Seller where they can be evaluated for placement. Any charges or costs incurred while dog is in the ownership, custody and/or care of the Buyer is their responsibility and Seller is not responsible for any such costs. Buyer will incur all costs associated with returning said dog to Seller.

Buyer acknowledges and agrees that they have read and understand the terms and conditions of our "Health Guarantee".

APPLICABLE LAW, JURISDICTION AND ATTORNEY'S FEES: This contract shall be construed and governed by the laws of California. Jurisdiction and venue for any dispute arising under or in relation to this contract shall be only in the County of Mariposa and the State of California.
